

# “BOARDS ON BUSES” CONTEST

## OFFICIAL RULES

The following promotion is intended for viewing in the 50 United States and D.C. only and is construed and evaluated according to Washington law. Do not enter this Promotion if you are not a legal resident of, and located in, the 50 United States or D.C. at the time of entry.

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

By participating in BOARDS ON BUSES (the “**Promotion**”), each entrant (or his or her parent or legal guardian if the entrant is under the age of majority in his or her state of residence) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of A HUGE PRODUCTION (“**Sponsor**”), which are final and binding in all respects. Sponsor is responsible for the collection and selection entries and the Promotion’s overall administration. Entrants should look solely to Sponsor with any questions, comments or problems related to the Promotion.

1. **ELIGIBILITY:** BOARDS ON BUSES (the “**Promotion**”) is open only to legal residents of the 50 United States and the District of Columbia who are at 18 years of age or older. Entrants under the legal age of majority in their state of residence must have permission to enter the Promotion from their parent or guardian. 3. **HOW TO ENTER:** Online: To enter online:

- Visit **your** INSTAGRAM or FACEBOOK page between 5/1/18 at 12:00AM PDT and 8/15/18 at 11:59PM PDT, allowing enough time to complete the following:
- Post a **public** photo or video (one minute or less in length) which includes BOTH a skateboard and a bus
- PLUS include a written story with your public photo or video post about your commute involving skateboarding/longboarding or a creative commute story combining skateboarding/longboarding with public transportation
- AND include the hashtag **#BoardsOnBuses**
- To be valid, entries must be received no later than 8/15/18 at 11:59PM PDT

4. **ENTRY CONDITIONS:** Limit 5 entries per person. The authorized account holder of the email address used to enter the Promotion is deemed to be the entrant. The “authorized account holder” is the natural person assigned to an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. **PRIZE:** First Place Winner will receive a skateboard deck from Subsonic Skateboards, 4 skateboard wheels from Orangatang Wheels, and 2 skateboard trucks from Paris Truck Co. Please allow 4 weeks for prize delivery from the time a winner provides delivery information to Sponsor. Taxes on prize, if any, are solely the responsibility of the winner. Winners of a prize valued at \$600 or more will receive a Federal Tax Form 1099. We recommend that you consult with your tax advisor if you have further questions. Sponsor reserves the right to substitute a prize of equal or greater value in its sole discretion, unless such substitution is prohibited by law. Sponsor may disqualify a winner and select an alternate winner if any prize is returned undeliverable. Prizes are non-transferable. Sponsor need not substitute a prize based on the winner’s request.

6. **ODDS OF WINNING:** The odds of winning depend on the total number of eligible entries received.

7. **WINNER SELECTION:** Judging will be based upon the following criteria: composition, artistry, creativity, and theme consistency. Applicable bus ridership rules plus Instagram, Facebook, and contest rules must be followed. Top three winning entrants will be selected by A HUGE PRODUCTION and contacted via Direct Message on INSTAGRAM and/or FACEBOOK on or around August 20, 2018. If a potential winning entrant is determined by Sponsor to be unqualified to participate in this Promotion or does not respond to Sponsor’s correspondence within 72 hours, the potential winning entrant will be disqualified and a new potential winning entrant will be selected according to next qualified based on aforementioned judging criteria.

8. **REQUIRED DOCUMENTATION:** The potential winning entrant may be required to complete an Affidavit of Eligibility and Release (“**Affidavit**”) in accordance with the instructions listed in the notification correspondence. Any entrant who fails or refuses to sign and return the required documentation within the time period as specified by Sponsor will be disqualified. If a potential winning entrant is considered a minor in the legal jurisdiction in which the entrant resides, then that entrant’s parent or legal guardian may be required to execute and return the Affidavit.
